

## Home and Community-Based Settings. 42 CFR 441.301(c)(4)

Our Home and Community-Based Settings is a Licensed CLHF Facility:

We ensure the following qualities to be determined based on the needs of each individual in our care as indicated in their person-centered service plan:

Our dedicated team of staff will provide and offer **full supports** and assist and enable **full access** to the **greater community**, integrated & including opportunities to seek **employment** and work in competitive integrated settings, engage in **community life**, control personal resources, and receive services in the community. It is our goal to enable, prompt and provide access to the degree of an individual living at home. We will have implemented a system to ensure we can provide this to all our patients regardless of the source authorizing their services. As a home and HCBS this is our obligation to all residents.

As this is a **private residential setting**, and to ensure all residence receiving care in our HCBS are **protected from eviction** we ask all patients to sign a **resident agreement** upon admission.

It is our mission to meet each residence goals based on the **individual's needs, preferences**, and, for residential settings and resources available for as identified & documented in the **person-centered service plan**.

As a Home and Community Based Provider we are a restraint free facility and inform them of the fundamentals and essence of a HCBS setting and the services and support it offers. To ensure each patient in our Facility is provided with their **rights of privacy, dignity and respect** (and Restraint) we ask them to sign our **freedom of choice** form to elect our HCB location for their needs, services and support.

### **Facilitates Individual Choices:**

**Initiative, Autonomy, Independence (including life choices) Daily Activities, Environment, Interactions, Visitors, Services, Support, Providers.**

### **Individual Privacy:**

To ensure each individual's **privacy and freedom** is provided in both **living units & sleeping units** our entrance doors can be locked by the individual, (for safety, keys are provided to appropriate staff only), **physical accessibility** to public areas, as well as **decor and furnishing** to their liking (and personal resources) in their dwelling areas.

Upon request residence can request a **transfer** or a Roommate change (all requests will be provided with in resources available and patients choice of action).

Our **Scheduled Meals and Activities** are posted for all. Additional needs and requests for **personal needs of travel, access, food** and alike can be request and **accommodated** as our internal, 3<sup>rd</sup> party as well as residences resources will enable.

If **conditions** must be made to any of the above alike natured supports, freedom, preferences or alike, assessment to the cause or need of such shall be **justified and explained** in the **person-centered service plan**.

### **Our Person-Centered Care Plan:**

Identifies and assesses all or any specific need to the individual.

Positive interventions and supports methods used for to all / any needed modifications.

Documentation of methods tried for outcome, results and residences needs fulfillment.

Clarity, description, cause, need to any and all direct care or conditions.
